FROM THE CHAIR



This has been an exciting year for JUSTICE on many fronts, marked by extraordinary work and an increasingly stable financial position.

Reimagining how our justice system might work is what put JUSTICE on the map over 50 years ago and in implementing our new strategy we have returned to being what the Lord Chief recently described as a 'really radical think tank'. The *Delivering Justice* working party report has demonstrated the potential of JUSTICE and its members to shape the debate about how our courts system operates and what access to justice really means.

As a Peer and therefore a 'consumer' of JUSTICE's work, I have been particularly delighted by the recent *Law for Lawmakers*, which provides a beginner's guide to the law for new MPs and Peers. This work epitomises the JUSTICE approach – balanced, thoughtful, accessible and always reliable. JUSTICE provides a 'bridge between law and law makers'. But bridges don't come cheap.

Last October I launched the Securing JUSTICE at 60 Appeal, and our thanks go to the amazing Appeal Patrons who have signalled their support for JUSTICE. Thank you also to those who supported the Law and Literature Series and particularly to the wonderful Julian Barnes, Robert

Harris, Dame Hilary Mantel and Ian McEwan for giving so generously of their time and insights for JUSTICE. At the time of writing we are over one quarter of the way to our 2017 target, and we are especially grateful to Freshfields, Skadden Arps and Harbour Litigation Funding for their leadership gifts.

JUSTICE is ambitious. The last year has shown what can be achieved by a small and committed staff, supported by an incredible membership, but imagine what we could do with more staff and more members? We need a successful Appeal to secure JUSTICE's future, but also to allow its innovation and influence to grow. As I said last year, if you have money, please make a donation to JUSTICE. FROM THE DIRECTOR



The last year has been a challenging but exciting year for JUSTICE, focused on implementing our new strategy.

The *Delivering Justice* in an Age of Austerity working party provided a litmus test for the strategy — would a group of our individual members, supported by a JUSTICE staff member and a corporate member, still be an appropriate vehicle for identifying and proposing change in the justice system? After almost a year of research, consultations and extensive meetings, I am pleased to report that the *Delivering Justice* report delivered. You can read more about its recommendations and our follow-up work on page 7. Our members are not idle. Another group is looking at litigation at the other end of the spectrum — those criminal cases that drag on at considerable cost to the taxpayer and potentially justice. Our Complex and Lengthy Trials working party will report later this year, and others are planned as we expand.

An equally important limb of the new strategy was to restore JUSTICE to financial security and allow our staff complement to grow to meet the challenges ahead. Under the leadership of the amazing Karyl Nairn QC, the *Securing JUSTICE at 60 Appeal* is underway and just over eight months in, we are at a quarter of our target.

There is a long way to go, but we are confident that with the support of the profession, JUSTICE can be transformed.

Already the Appeal is providing us with much-needed capacity. We have added a Head of Administrative Justice and a CILEx Legal Administration Apprentice to our team, with another lawyer to be recruited soon. The Appeal has also allowed us to honour our commitment to pay interns – who provide critical legal and non-legal support – the London Living Wage. This has dramatically opened up the field of candidates available to us and ensures that an internship with JUSTICE is determined by individual merit, rather than financial circumstance.

As ever, I am indebted to our amazing staff and our Board and Council. And to every person who has signed up or renewed their membership, submitted evidence to a working party, written us a cheque or otherwise demonstrated support for JUSTICE. Thank you.

DELIVERING JUSTICE IN AN AGE OF AUSTERITY

In April 2015, the first working party of the JUSTICE membership in over 15 years issued its report, proposing radical change to the handling of disputes and advice in the civil courts and tribunals. Diminishing legal aid, coupled with the reality that most people of modest means have been long ago priced out of legal services, provided the context for the working party's report. Chaired by the Rt. Hon. Sir Stanley Burnton, the working party recommends:

- The introduction of a new primary dispute resolution officer (a "registrar") who will be responsible for proactively case managing disputes as well as actively resolving the majority of cases through a combination of mediation and early neutral evaluation. Judges will continue to resolve those cases requiring high-level judicial expertise in the ordinary way.
- An integrated online and telephone platform offering comprehensive legal information, advice and assistance, helping litigants to navigate their way through the newly reformed justice system.

Sir Stanley was joined by Sir Geoffrey Bindman QC (Hon), Andrea Coomber, Carlos Debezies, Amanda Finlay CBE, Professor Rosemary Hunter ACSS, Sir Paul Jenkins KCB QC, Andrew Lidbetter, Andrew Lockley, Ruchi Parekh, Nigel Pleming QC, Lucy Scott-Moncrieff CBE and Professor Richard Susskind OBE. Their work was generously supported by Herbert Smith Freehills LLP.

The report has been widely circulated and well received among decision makers. The Lord Chief Justice, Lord Thomas of Cwmgiedd, explicity referenced JUSTICE's report in his recent address to The Constitution Unit as:

"ideas that would not simply make the existing processes better, but would recast the delivery of justice so that it became again accessible at a cost people could afford and therefore use."

We are now focused on follow-up on the recommendations, engaging with key stakeholders in HM Courts and Tribunals Service and senior judiciary, civil society and politicians across the spectrum on how our proposals might be taken forward.

"The challenge of this report was to propose reforms in the judicial system which would mitigate the denial of justice caused by savage government funding cuts without compromising fundamental safeguards – not least the right to a fair trial guaranteed by article 6 of the European Convention on Human Rights. RESEARCH AND ANALYSIS: THE FUTURE OF JUSTICE

COMPLEX AND LENGTHY TRIALS

Another working party of our members is busy looking at very different types of cases; those trials – fraud, terrorism and serious crime – which last over three months, at considerable cost to the tax payer, the parties and often to justice. Chaired by Sir David Calvert-Smith, our Complex and Lengthy Trials working party has been at work since December. Sir David is joined by Douglas Day QC, Anand Doobay, Anthony Edwards, Stephen Gentle, Ben Myers QC, HHJ Rebecca Poulet QC, D. Ch. Supt. Paul Richardson, Clare Sibson, Ros Wright CB QC and Professor Michael Zander QC. The work is supported by Simmons & Simmons.

Considering investigation, pre-trial and trial processes, the work builds on the recent report of Sir Brian Leveson. The working party is benefiting from the on-going engagement and support of the judiciary, the Ministry of Justice and HM Courts and Tribunals Service.

The working party will report later in the year.

IN THE DOCK

There are some aspects of our justice system which have been around so long that we don't question their impact on access to justice and fair trial. One is the use of the dock in criminal trials. In July the Lord Chief Justice spoke at the launch of *In the Dock:* Reassessing the use of docks in criminal trials which recommends

the abolition of the dock, suggesting that justice would be better served by defendants sitting next to their lawyers. Our concerns include that the use of the dock impacts upon the defendant's right to a fair trial, in particular: effective participation in one's defence; preserving the presumption of innocence; and maintaining dignity in the administration of justice. It considers alternative security measures for the small percentage of cases in which security is an issue. With Government attention turning to how court buildings are best used, we will work to challenge the use of this Victorian relic.

JUSTICE was supported with comparative research by academics from the London School of Economics and Political Science and by Dechert LLP.

LAW FOR LAWMAKERS

Central to JUSTICE's mission is bringing a better understanding of good law and legal process to those who make our laws. To this end, we have published *Law for Lawmakers: A JUSTICE Guide to the Law.*

This Parliament will face a number of crucial constitutional questions – on the protection of human rights, UK membership of the European

Union and on devolution and the state of the Union. Working with an Advisory Group of MPs and former MPs from across the political spectrum, legal academics and practitioners, JUSTICE produced a guide focusing on the key legal principles of our constitution at the heart of the important debates to come.

We have distributed copies of the guide to every new member of Parliament and we are planning to offer follow-up seminars for MPs, Peers and their staff over the course of Parliament.

BRIEFINGS

JUSTICE has continued to provide practical briefings for officials, MPs and Peers, in writing and in person, free from party political influence. From briefings on the next stages of the EU Roadmap on procedural safeguards, to the Counter-Terrorism and Security Bill, to JUSTICE Scotland's response to the Post Corroboration Safeguards Review, we have worked with Westminster and Whitehall, Holyrood and Leith, and with Brussels and Strasbourg, to highlight the

significant implications of policy initiatives for civil, criminal and administrative law and practice.

Our main focus this year has been on the Criminal Justice and Courts Bill (CJC), now Act (CJCA), and its implications on both criminal justice and judicial review. Working with other NGOS, we held successful seminars on each aspect of the Bill and we produced detailed briefings on both Parts 1 - 3 (criminal justice) and Part 4 (judicial review). Notably, the Part 4 briefing was referenced during debate on the floor by a number of Peers and three of four amendments supported by JUSTICE were passed in the House of Lords.

CONSULTATION RESPONSES AND INQUIRIES

JUSTICE provided responses to a number of consultations and inquiries by Government and other relevant organisations and institutions. This included submissions to the Intelligence and Security Committee Privacy and Security Inquiry and to David Anderson QC's consideration of the Regulation of Investigatory Powers Act 2000, drawing closely on our 2011 recommendations for a new surveillance framework in *Freedom from Suspicion*, which were reflected in his final report *A Question of Trust*.

JUSTICE IN THE COURTS

JUSTICE is committed to third party interventions in cases likely to have a functional impact on the effective and fair operation of the justice system as a whole, where our expertise may assist the court. While this work has come under particular political challenge this year, the broad support for the work of JUSTICE and other interveners, particularly from former Law Lords and Supreme Court Justices, has been encouraging.

JUSTICE TRIES TO INFLUENCE THE DEBATE NOT TO CONTROL IT. IT CAN LOOK CRITICALLY AT AN ISSUE AND MAKE SUGGESTIONS, IT CAN INTERVENE IN CASES WITH THOROUGH RESEARCH THAT PARTIES ARE UNABLE TO UNDERTAKE, AND IT HAS INFLUENCE WITH CIVIL SERVANTS AND POLITICIANS BEHIND THE SCENES. ITS STRENGTH IS IN ITS UNFAILING OBJECTIVITY.

We were heavily involved in the consideration in Parliament of various aspects of the Criminal Justice and Courts Bill. One particular focus was Part 4 of the Bill and its impact on third party interventions and judicial review cases. One provision impacting directly on our own work sees third party interveners possibly exposed to costs orders in cases in the Court of Appeal and below.

We are strategizing with other frequent interveners and funders of NGO litigation to assess the implications of the Act for intervention work and how we might best respond.

Belhaj & Anor v Straw & Ors

Alongside Amnesty, ICJ and REDRESS, JUSTICE intervened before the Court of Appeal on the scope of "state immunity" under common law and how far this is consistent with international law and the ECHR. The case is now before the Supreme Court, where we have also been granted permission to intervene.

Nunn v Suffolk Police

Last year, JUSTICE intervened in the case of *Nunn v Suffolk Police*, a case concerning the duty upon public authorities to disclose material to a convicted person who is investigating a claim of miscarriage of justice. While the 18 June Supreme Court judgment dismissed the appeal, it did clarify the duty of post-conviction disclosure to be wider than the High Court had previously held and underlined the important role that solicitors and other groups play in uncovering wrongful conviction.

JUSTICE, BEYOND LAWYERS AND BEYOND LONDON

THE JUSTICE STUDENT NETWORK

Following dedicated funding from the Legal Education Foundation we have reinvigorated the JUSTICE Student Network (JSN), creating a valuable and unique resource, enhancing the education, employability and careers of law students interested in law reform issues.

Our website has been developed and now enables access to multimedia resources including recordings of JSN events, webinars with the JUSTICE policy team and interviews with established figures in the world of law, alongside the existing and updated case notes, briefings and toolkits.

The addition, in October last year, of a dedicated staff member to support the development of the Network means we have been able to build relationships with more universities across the country; hosting seminars and supporting student events, we have increased our reach far beyond London.

In March this year we also launched the JUSTICE externship programme to further increase the accessibility of JUSTICE's work and a career in law to students who might find longer term

internships tied to London difficult for financial or geographical reasons. We will be hosting externs twice a year, to work remotely on JUSTICE projects, and this scheme will run alongside our established internship programme.

JUSTICE SCOTLAND

Launched in July 2012, and chaired by Dorothy Bain QC since April 2015, JUSTICE Scotland operates largely as a volunteer group of leading lawyers, with support from London staff. Its aims are aligned to that of JUSTICE and its focus is to promote the rule of law and human rights in a legal context with particular relation to devolved matters. It has so far contributed significantly to debate about reform of the criminal and civil justice systems in Scotland.

In April this year, JUSTICE Scotland launched a new strategy setting out its key objectives for the next three years. Capitalising on the expertise and eminence of its membership and its position as the sole organisation to focus its efforts in this way, JUSTICE Scotland is developing projects including:

- Accessing legal assistance in the police station, with particular focus on suspects with mental health and learning difficulties.
- Procurement and admissibility of expert evidence in the Scottish courts.
- Safeguarding Legal Professional Privilege.

Last year saw our Annual Human Rights Law Conference brought in-house for the first time. Five members retired from Council;



FINANCE

FINANCE

JUSTICE has had an encouraging year financially and has ended the 2014/15 financial year with a surplus of £50,432, which includes £54,589 in unspent restricted funds. Although we have a deficit of £4,157 in unrestricted funds, this is an improvement on the deficit of £69,961 from 2013/14. The improvement over the prior year is largely due to our focus on fundraising. We have received funding from the Legal Education Foundation to support and develop our Student Network and from Unbound Philanthropy and the Law Society for our work on the Administration of Justice. We also successfully launched our Securing JUSTICE at 60 Appeal on 28 October 2014; to date we have raised over £500.000 and aim to have reached £1 million by October 2015.
