## Transforming Justice – Court Modernisation and Digital Exclusion

The UK Government White Paper *Transforming Our Justice System* (September 2016), and subsequently the introduction of the Prison and Courts Bill in the last Parliament, confirms the plans of the Ministry of Justice and senior judiciary to 'automate and digitise the entire process of civil money claims by 2020' and the 'interactive triage' role envisaged for litigants-in-person using the 'Online Court' for certain civil proceedings. Modernisation and digitisation – including greater use of online procedures and virtual hearings – will also extend to tribunals and criminal proceedings. Traffic offences are already dealt with online in most parts of the country.

This conference will give you the opportunity to meet the JUSTICE team and some experts in this field, as well as new practitioners, to discuss the future justice system. We will be running exciting and thought provoking workshops on some of the challenges of digitisation for people navigating the criminal, civil and immigration and asylum court processes.

You will also have the opportunity to hear about the experiences of our panel of junior lawyers and receive invaluable advice about the journey into legal practice. JUSTICE Director, Andrea Coomber, will end the day in conversation with leading senior practitioner, Alexandra Marks CBE, and you will have a chance to quiz her about her career.

#### 1. Court Modernisation and Sexual Offences Tariq Desai,

Lawyer, Criminal Justice, JUSTICE

When prosecuting sexual offences, it is often one person's word against another's, with little available evidence. The nature of the crime also means that many complainants are vulnerable, making the court experience incredibly difficult for them. Modernisation, such as pre-recorded evidence and video links may make prosecutions easier, but may raise also fair trial issues.

Join us to discuss the impact of court modernisation on the prosecution of sexual offences.

#### 2. Transforming Immigration and Asylum

The Reform Programme presents an opportunity to address flaws in the current system, such as the quality of Home Office decisions and the quality of legal representation. It also poses challenges. For example, can migrants effectively participate in hearings via video-link when they struggle with English and are unfamiliar with our legal system?

### 3. Digital exclusion from 21st century justice? Rachel Jones, Lawyer Civil Justice, JUSTICE

An 'Online Court' will be created for low-value money claims. Groups, such as the elderly who are unfamiliar with computers, people with learning difficulties who need support to understand, and illiterate people who cannot read webpages, risk being digitally excluded from this new court.
