I have been a paid-up member of JUSTICE since 1962. A few years ago I became a Friend of JUSTICE, and more recently I was a patron of its successful £2 million appeal for funds. This new money has enabled the charity to enlarge its complement of skilled staff and also to carry out much-needed repairs to its freehold building in Carter Lane. I have contributed as much as I could – and also to the new £1 million call for funds to revamp the building and make its facilities far more receptive to modern needs.

The success of the first appeal, coupled with the inspirational leadership of its director Andrea Coomber, has enabled JUSTICE to rekindle memories of its glorious past. I well remember, for instance, how its campaigning work led to the creation of the Office of Ombudsman and the Criminal Cases Review Commission; to the reforms to prosecutorial practice in the 1980s, and to an awareness of the need to bring surveillance activities within the umbrella of the rule of law.

During the last two years JUSTICE Working Parties have published a series of high quality reports: *Delivering Justice In An Age of Austerity*; *Complex and Lengthy Criminal Trials*; a blueprint for 'popup' courts; *Increasing Judicial Diversity*; and *Mental Health and Fair Trial*. None of this work would have been possible without the committed support, both practical and financial, of so many of its members. When it is given the support it needs, JUSTICE has always punched above its weight.

There is another way in which we can all help. Over the years JUSTICE, like other charities, has benefited greatly from legacies left to it by its admirers. No Inheritance Tax is charged on money left to a charity, and even a small legacy can go a long way. This is why I, and others like me, have given appropriate instructions to our executors. If you have not, please think of doing so now. For all of us who are committed to advancing the rule of law there can be few more deserving causes.
